<u>RECOMMENDATION</u>: That the Board of Directors adopt Resolution No. _____, approving the District's Final Fiscal Year 2022-23 Operating Budget, and Resolution No. _____, approving the District's Final Capital Improvement Program (CIP) Budget for Fiscal Year 2022-23.

<u>BACKGROUND</u>: The District's Budget Policy FIN-07-2078, as revised June 12, 2019, calls for the Board of Directors' approval of its Final Operating and CIP Budgets by June 30th.

Each year, the District conducts a Budget Workshop that provides the Board with a view of its Proposed Budgets for the coming fiscal year and obtains the Board's feedback and guidance. This year, the Workshop was conducted on May 25, 2022 and focused on staff's recommendations for the Operating and CIP Budgets for FY 2022-23. Prior to the May workshop (in March, 2022), the Board received a presentation of staff's Preliminary Operating and CIP Budgets for FY2022-23 for comment/direction. As well, detailed Committee-level reviews of the Proposed FY 2022-23 Budgets were conducted in May, 2022 with the Personnel Committee (Salary and Benefit Budgets), the Facilities Committee (CIP Budget), and the Finance Committee (overall Operating and CIP Budgets).

OF NOTE: The proposed Final Operating Budget allows for the funding of those CIP projects that rely on funding from the District's General Fund, though it relies on a proposed contribution to the Deferred Maintenance Reserve in FY2021-22 that will be used to help fund FY2022-23 CIP projects that will require the use of General Funds. At a high level, the FY21-22 operating results, enhanced by the one-time COVID Relief income of \$1.2 million, will help fund next year's CIP projects, including the \$1.6 million FY2022-23 CIP project to replace the two synthetic turf fields at Robertson Park.
